Objective:

To provide Scholarships to brilliant but poor students for their career in Education after graduation or in any field such as sports, cultural, etc to meet the expenses while pursuing his / her higher studies and for future career.

Eligibility for Scholarship:

1. Student should be full time student of all the semesters / years of undergraduate degree programs of the College.
2. He / She shall not be failure of any semesters examinations of the degree program.
3. He / She should apply for the scholarship in the prescribed form within the last date as announced by the college every year.
4. Parental income of the student shall not exceed Rs. 2.5 Lakh per annum.

Scope:

- (i) The scholarship will be awarded on the basis of academic merits of all examinations of degree programs or on the basis of performance of the students in sports or any field.
- (ii) It may not be awarded in case of non-availability of deserving candidate.

No. of Scholarships Category (a) Two open scholarships of Rs. 25000/- each.

Category (b) Three Scholarships of Rs. 5000/- each for students admitted to PG program from campus category.

Selection Procedure:

- (a) Applications in the prescribed form for Late Rajendra Malpani and Late Sarojdevi Malpani Scholarships will be invited by the college on or before last day of September every year.
- (b) All such applications shall be placed before the Scrutiny Committee comprising of all Heads of the Departments under the Chairmanship of Principal.
- (c) The Scrutiny Committee shall recommend six names from category (a) and nine from category (b) in order of merit and with specific remarks to the scholarship committee for final award.

N.B.

4. Income for the purpose of Means Test is defined as under:-
 - a) In the case of salaried class, basic pay plus income if any from other sources and would not include allowance like Dearness Allowance, City Compensatory Allowance etc.
 - b) In the case of income from source liable to income tax, income computed (after deduction for rebate able items) for the purpose of assessment of income tax, as per Income Tax Rules for the year.
 - c) In the case of income not liable to income tax, such as income from Agriculture, etc. the net income that is arrived at after deduction expenditure incurred for earning that income.
